The meeting was called to order by Chairman Tangen who expressed appreciation to the people for attending the meeting today. It was pointed out that many people had participated and contributed their views and suggestions during the workshop type meetings which had been conducted throughout the state in 9 geographical areas in connection with the 1974 Five Year boundary review. Today's meeting had a single purpose--to review all the requests for boundary amendment that have been brought to the attention of the Commission and also proposals that the Commission itself has initiated for reconsideration. Chairman Tangen explained that staff will review each of these items which were identified by numbers and letters on the District Maps posted on the wall. Thereafter, the Commission will act to propose certain items for formal public hearing by islands and regions. The dates, times and places of the public hearings will be announced throughout the state well in advance of the hearing dates. It was emphasized that the items which are proposed for public hearing do not necessarily constitute a recommendation by the Commission--merely that there was sufficient interest and merit

to warrant a public hearing.

ISLAND OF OAHU

Mr. Tatsuo Fujimoto, Executive Officer, explained that the island will be divided into 3 areas--Windward (Kahuku to Kailua), Leeward-Central (Ewa to the North Shore), Honolulu Proper (Pearl City to Hawaii Kai).

It was noted that the following items were proposals for amendment presently before the Land Use Commission:

A motion was made by Commissioner Oura as follows: "Pursuant to the provisions of HRS Section 205-3, I move that the Commission direct the Executive Officer to prepare district classification maps showing proposed land use district boundaries for the West Region of the island of Hawaii. I further move that such maps set forth the existing boundaries for this region, except that the following proposed changes be shown: Items 1, 2, 4, 9, 10, 14, 17, 20 and 21; also Q, R, S, T, U, V, W, X, Y, Z, AA, BB, and CC as shown on the maps presently before the Commission.

The motion was seconded by Commissioner Yamamura and the Commissioners were polled as follows:

The motion was carried.
