NOTICE OF A FINDING OF NO SIGNIFICANT IMPACT

THE OFFICE OF PLANNING AND SUSTAINABLE DEVELOPMENT, STATE OF HAWAII ("OPSD"), has no objection to Petitioner Lanai Resorts, LLC dba Pulama Lanai's ("Petitioner") Motion to Issue Notice of a Finding of No Significant Impact ("Motion") for its proposed 200-acre industrial subdivision, pursuant to Hawaii Administrative Rules ("HAR") § 11-200.1-22.

OPSD provided comments on two versions of the Draft Environmental Assessment, and Petitioner addressed OPSD's concerns related to HAR § 11-200.1–18 except for providing a conceptual site plan showing the anticipated location of each of the proposed relocated and new uses. Nevertheless, OPSD finds that the Final Environmental Assessment meets the requirements of HAR § 11-200.1–21 and therefore has no objection to Petitioner's Motion for the LUC to issue a notice of a Finding of No Significant Impact. OPSD looks forward to reviewing a more detailed conceptual site plan when the final District Boundary Amendment Petition is filed.
