ORDER GRANTING PETITIONER'S MOTION TO WITHDRAW PETITION WITH PREJUDICE

On June 13, 2007, the Eric A. Knudsen Trust ("Petitioner") filed a Motion To Withdraw Petition ("Motion"), pursuant to section 15-15-70, Hawai'i Administrative Rules ("HAR"). An Affidavit Of Stacey T. J. Wong, Trustee of Petitioner ("Affidavit"), was attached to the Motion. In the Affidavit, Mr. Wong stated, among other things, that in light of recent and anticipated changes in the market and other economic conditions affecting Kaua'i, he re-examined the feasibility of the proposed development. Mr. Wong concluded that Petitioner's resources could be better utilized for Petitioner's other projects, and consequently instructed Petitioner's counsel to file the Motion.

On July 10, 2007, the State Office of Planning ("OP") filed a Statement Of No Opposition To The Withdrawal Of Petition.

On July 11, 2007, the Land Use Commission ("Commission") received correspondence from Sherry P. Broder, Esq., on behalf of Intervenor Office of Hawaiian Affairs indicating that the Office of Hawaiian Affairs had no position on the Motion and consequently would not be making an appearance at the Commission's hearing on the matter.

On July 12, 2007, the Commission held a meeting in Līhu'e, Hawai'i, on the Motion. Walton D. Y. Hong, Esq., appeared on behalf of Petitioner. James K. Tagupa, Esq., appeared on behalf of the City and County of Kaua'i Planning

Department. Abe Mitsuda appeared on behalf of the OP. Kalanikumai Ka Maka 'O Na Ali'i Hanohano, Ken Taylor, Terrie Hayes and Cheryl Lovell-Obatake provided public testimony on the Motion.


At the meeting, Petitioner provided a presentation on the Motion. The parties in this proceeding had no objections to the Motion. Following discussion, a motion was made and seconded to grant Petitioner's Motion. There being a vote tally of 6 ayes and 3 absent, the motion carried.

ORDER

motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause for the motion,

HEREBY ORDERS that Petitioner's Motion be GRANTED with prejudice. Accordingly, any petition for boundary amendment for the same request involving the same land in the above-entitled docket shall be subject to the provisions of section 15-15-76, HAR.
