# ORDER REFUSING TO ISSUE DECLARATORY ORDER

On February 15, 2008, Colleen Hanabusa, Esq., filed a Petition for Declaratory Orders and Request for Hearing ("Petition") on behalf of herself and the Ko Olina Community Association ("KOCA") (collectively "Movants").

On February 21, 2008, the City and County of Honolulu Department of Environmental Services ("Applicant") filed its Memorandum in Opposition to Petition for Declaratory Orders and Request for Hearing.

On April 24, 2008, the LUC resumed its meeting on the Movants' Petition and Supplemental Petitions in Conference Room 405, Leiopapa A Kamehameha Building, in Honolulu, Hawai'i. Colleen Hanabusa, Esq., and Ken Williams were present on behalf of the Movants. Gary Y. Takeuchi, Esq., was present on behalf of the Applicant. Following discussion, a motion was made and seconded to refuse to issue a declaratory order in this matter as it may affect the interests of the LUC in litigation that is pending relating to the extension of the deadline to accept solid waste at the WGSL. There being a vote of 8 ayes, 0 nays, and 1 absent, the motion carried.

#### **ORDER**

The LUC, having duly considered Ms. Hanabusa's and KOCA's Petition and Supplemental Petitions, the Applicant's Memoranda in Opposition, the oral arguments presented by the parties in this proceeding, and a motion having been made at a meeting conducted on April 24, 2008, in Honolulu, Hawai'i, and the motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause for the motion,

HEREBY REFUSES to issue a declaratory order in this matter as it may affect the interests of the LUC in litigation that is pending relating to the extension of the deadline to accept solid waste at the WGSL.
