WHEREAS, on June 4, 2003, Kuleana Ku'ikahi, LLC; Makila Land Company, LLC; Kauaula Land Company, LLC; and Launiupoko Associates, LLC notified the Land Use Commission ("Commission") of their agreement to withdraw the Petition For A Declaratory Order filed by Kuleana Ku'ikahi, LLC in the above-entitled matter;

WHEREAS, by Order Regarding Withdrawal Of Petition For A

Declaratory Order ("Order") dated July 2, 2003, the Commission allowed the

withdrawal of the Petition For A Declaratory Ruling, without prejudice, with the

understanding that the parties were to submit their status report on their mediation

efforts to this Commission within six months of the Order;

WHEREAS, after due consideration of the oral and written arguments of the parties and the entire record in this matter, a motion was made at its meeting on July 22, 2004, in Makena, Maui, Hawai'i, to deny the Petition Of Kuleana Ku'ikahi For Order Re-Opening Proceedings And For Additional Relief and the motion received the affirmative votes required by section 15-15-13, Hawai'i Administrative Rules,

NOW, THEREFORE, it is hereby ordered that the Petition Of Kuleana Ku`ikahi For Order Re-Opening Proceedings And For Additional Relief be DENIED.
