SCRep. 801-72 Health on J.C.R. No. 51

The health committee held hearings on S. B. 2074-72 which would have accomplished by statute what this Resolution requests the Governor to do.

The Office of Comprehensive Health Planning has been located in the Department of Health. The concensus of testimony by community health experts was that good, comprehensive health planning could be done better from the Governor's office. From this position it could cut across departments to gain information and establish policy.

During the testimony Dr. Hirobumi Uno of the Governor's office informed the committee that the Governor himself favors this action and is planning to accomplish it in the near future. Therefore, the Committee has filed S. B. 2074-72 and, for the purpose of supporting the Governor's plan, recommends adoption of S. C. R. 51.

Your Committee on Health is in accord with the intent and purpose of S.C.R. 51 and recommends its referral to the Committee on Ways and Means for further consideration.

## SCRep. 802-72 Judiciary on H.B. No. 371

The purpose of this bill is to exempt the rules and regulations prescribed during a civil defense emergency period from Chapter 91, Hawaii Revised Statutes.

Your Committee finds that in the event of a civil defense emergency the governor must be empowered to act decisively to a variety of situations, some of which cannot be foreseen. As a result there will not be enough time to go through the formalities of holding public hearings under said Chapter 91.

Your Committee on Judiciary is in accord with the intent and purpose of **H.B. No. 371** and recommends that it pass third reading.

## SCRep. 803-72 Economic Development on H.B. No. 2249-72

The purpose of this bill is to require the State Land Use Commission to hold a public hearing in the appropriate county in accordance with the requirements of Section 205-3, Hawaii Revised Statutes, after 60 days but within 120 days of the original receipt of a petition for any change in the boundary of any district.

Under existing law said Commission is required to advertise a public hearing to be held on the appropriate island in accordance with said Section 205-3. There is a possibility that advertising of a hearing notice may be done on the 120th day and be in conflict with the time limitation period of 60 to 120 days.

Your Committee upon consideration of this bill recommends that it be amended to allow the State Land Use Commission to modify a petition for a district boundary change by imposing conditions necessary to uphold the general intent and spirit of Chapter 205, Hawaii Revised Statutes, and to assure substantial compliance with representations made by the petitioner in seeking a boundary change. Such conditions, if any, shall run with the land and be recorded in the bureau of conveyances.

Your Committee on Economic Development is in accord with the intent and purpose of H. B. No. 2249-72, as amended herein, and recommends its passage on third reading in the form attached hereto as H. B. No. 2249-72, S. D. 1.

SCRep. 805-72 Judiciary on H.B. No. 2376-72

The purpose of this bill is to allow the head of any family to produce for family use and not for sale an amount of wine not exceeding 200 gallons per annum.

Existing federal law allows such production of wine whereas existing state law prohibits such production of wine. The bill would bring state law in conformity with federal law.

The language of the amendment conforms to the language of the federal law. Beer is not included because federal law absolutely prohibits the production of beer at any place other than a qualified brewery. Your Committee on Judiciary is in accord with the intent and purpose of the bill and recommends that House Bill No. 2376-72, H.D. 1, pass second reading and be referred to your Committee on Ways and Means for further consideration.
