

4	On September 17th, we will be having a					
5	special meeting as a result of time frame associated					
6	with special permits to adopt the order for Mahi					
7	Solar. On September 22nd, we will be hearing DR21-					
8	73, which is the Chipchase matter and A15-7798,					
9	which is Waikapu.					
10	On October 13th and 14th, we have penciled					
11	in continuation of the IAL matter. That is					
12	tentative pending receipt of a decision by the					
13	attorney general with regards to the issues that					
14	were previously raised.					
15	On November 10th, we'll be hearing A21-					
16	810, which is Hokuao. That's a 201H project. On					
17	November 24th, we will be adopting the order in that					
18	matter.					
19	On December 8th, we will be hearing the					
20	Airport Hotel matter district boundary amendment,					
21	which is a Maui DBA. And that takes us through the					
22	end of the year.					
23	CHAIR SCHEUER: Thank you, very much.

5 Anybody who wishes to testify on the 6 modification of the number of copies required for 7 filing?

8 With that, Mr. Orodenker, would you walk 9 us through the proposal.

10 MR. ORODENKER: Thank you, Mr. Chair. As 11 mentioned, Section 15-15-40 governs the filing 12 requirements and the number of copies that are 13 required for filings. Currently it provides one 14 electronic copy, the original, and one paper copy 15 should be filed with the Commission.

As electronic media has become more and 16 17 more prevalent, we found that we're really just 18 discarding one of the two hard copies, the extra 19 hard copy. So we'd like to request the Commission 20 -- Section 15-15-40 provides that the Commission by 21 order may modify the number of or format of copies 22 required under this section. So we're requesting 23 that the Commission issue an order allowing us to 24 change the filing requirements to one electronic 25 copy and the original.

19	the motion and it was a last-minute filing, we were				
20	unable to agendize the matter for argument today.				
21	Because of the nature of the motion, we				
22	believe it's necessary to consider or dispense of				
23	the motion prior to starting the proceedings on the				
24	petitioner's motion to amend, and so in order to				
25	comply with statutory requirements, this matter will				

be deferred until September 8th and 9th, 2021. 1 2 With that, we will take a brief recess to 3 prepare for the next agenda item. Recess at the discretion of the Chair. 4 5 (Zoom recording remained on continuously.) 6 CHAIR SCHEUER: Commissioner Okuda, we're 7 in recess -- yes? 8 COMMISSIONER OKUDA: Chair, I was going to 9 ask on the record about three or four documents. 5 COMMISSIONER OKUDA: Thank you, Mr. Chair. 6 This is Gary Okuda. May I ask the parties in the 7 Kihei High School matter to supplement the record 8 with certain documents which were referred to either 9 in public testimony or in the submissions by the 10 Department of Education.

11 And the specific documents that I ask be 12 supplemented is first a document which was referred 13 to in the public testimony of Council Member King, K-i-n-g. That document was entitled Safe Routes to 14 15 Kihei High School: Pedestrian Route Study, Kihei, Maui, 2014. So that would be the first document: 16 17 Safe Routes to Kihei High School: Pedestrian Route Study, Kihei, Maui, 2014. And that document was 18 19 prepared by or prepared for Group 70 and the Hawaii 20 Department of Education by the Walkable and Livable 21 Communities Institute.

22 CHAIR SCHEUER: Commissioner Okuda, may I23 ask you to pause for one second.

CHAIR SCHEUER: So I just want to check



1	with Ms. China and Mr. Orodenker. I believe what's
2	going to happen here is Commissioner Okuda simply is
3	asking the parties when they do appear in front of
4	us on the main substantive motion to be prepared to
5	provide certain information. I don't think it
6	requires any discretionary action of me as the chair
7	and so I'm prepared to allow this to ease the
8	party's abilities to be prepared for any discussion
9	of the matter when it comes to that main motion.
10	Is that acceptable or am I somehow
11	biassing it by not having first dispensed with the
12	request to have me recused?
13	MS. CHINA: I think it's mostly procedural
14	so I think it's fine.
15	CHAIR SCHEUER: Okay. Sorry for the
16	interruption, Commissioner Okuda. Please proceed.
17	COMMISSIONER OKUDA: Thank you, Mr. Chair.
18	And let me clarify: I'm just making a request. If
19	the parties decide not to supplement the record,
20	then the record will proceed as it stands. I'm just
21	making this request.
22	The second document that I request the
23	parties supplement is a document that was referred
24	to in the Department of Education's submission, and
25	that is a document titled Pedestrian Crossing

Guidelines for Texas, and it's a report, dated
December 2000, and the report number, which was also
referred to in the Department of Education's
submission was Report No. FHWA/TX-01/2136-2. So
that would be the second document that I request the
parties supplement the record with before the
hearing.

And the final items that I ask the parties 8 9 supplement are the studies that were referred to in 10 that document which I just mentioned which are 11 referred to or identified at page 47 of the 12 document, and that was described as a quote, 13 Benefit-Cost Analysis, and the documents which the 14 author of the report, and I quote, "encouraged to 15 consult," closed quote, were these two documents and 16 I ask that these two documents also be supplemented 17 in the record.

18 They are first a document identified as 19 NCHRP Report 189 and in quotations that's titled, 20 "Quantifying the Benefits of Separating Pedestrians 21 and Vehicles," closed quote, 1978. And the second 22 document referred at page 47 of the report, the 23 prior report that I -- or the master report that I 24 referenced is NCHRP Report 240 titled quote, "A 25 Manual (inaudible) of Separating Pedestrians and

Vehicles," closed quote, 1981. 1 So, Mr. Chair, it's just my request that 2 3 the parties supplement the record with those documents. If they choose not to do so, then I 4 quess we will proceed with the record as the record 5 6 is stated. Thank you, very much, Mr. Chair, and 7 nothing further. 8 CHAIR SCHEUER: Okay. Thank you. Mr. 9 Orodenker. 10 MR. ORODENKER: Commissioner Okuda, if you could e-mail me that request, I will make sure that 11 12 it gets to the parties in writing. 13 COMMISSIONER OKUDA: This is Gary Okuda. 14 I will do so, Mr. Orodenker. Thank you, very much. 15 MR. ORODENKER: Thank you. 16 CHAIR SCHEUER: Okay. With that, we are 17 done with any consideration of the Kihei High School 18 matter on today's agenda. It's being deferred to 19 September 8th and 9th, including the motion to have 20 me recuse or disqualify me. 21 We now have our next agenda item which is 22 an executive session pursuant to HRS 925(a)(2) to 23 consider personnel matters where considerations of 24 matters affecting privacy is involved. I've been 25 informed no public testimony was submitted regarding

this executive session. 1 2 Is that still correct, Mr. Hakoda? 3 MR. HAKODA: Yes, Chair. No testimony received. 4 5 CHAIR SCHEUER: Okay. I will entertain a 6 motion to go into executive session. If the motion 7 passes where we're considering employment matters, the commissioners will leave the meeting. We'll go 8 into a separate Zoom meeting for deliberations 9 10 during executive session and we'll return to this 11 meeting, though the return to this meeting, there's 12 nothing further on the agenda and we're simply going 13 to gather long enough to adjourn so there will be no 14 further public meaningful business to conduct 15 (inaudible). 16 Is there a motion to go into an executive 17 session? 18 COMMISSIONER WONG: Chair, this is 19 Commissioner Wong. 20 CHAIR SCHEUER: Commissioner Wong. 21 COMMISSIONER WONG: Before I make the motion, I just wanted to inform if this motion does 22 23 pass (inaudible) stated that e-mail I sent to all 24 the commissioners on the executive session. Just to 25 remind them, it's from me personally. So if it does

pass, then I also will make the motion to move into 1 2 executive session. 3 CHAIR SCHEUER: Okay. A motion has been made to move into executive session by Commissioner 4 5 Wong. Is there a second? Commissioner Cabral. 6 COMMISSIONER CABRAL: Yes, I will second 7 Commissioner Wong's motion for executive session. CHAIR SCHEUER: Okay. All in favor, 8 9 please signify by saying aye and raising your hands. 10 Does anyone oppose? Signify by raising your hand and saying nay. No one opposed. 11 We will go into executive session. And 12 13 again, for those who are on this call, that is essentially the end of our public business. We will 14 15 return briefly to this meeting to adjourn but that's it. Thank you, very much. 16 17 Commissioners, follow the instructions in the e-mail from Commissioner Wong. 18 19 (At which time the Commission went into 20 executive session at 9:24 a.m.) 21 CHAIR SCHEUER: Okay. It is 10:25. We 22 have left executive session. We are back into 23 regular session. Mr. Orodenker, is there any 24 further business? You're muted, Mr. Orodenker. 25 MR. ORODENKER: Not that I'm aware of, Mr.
