In August 1972 the Land Use Commission initiated a petition to restore the urban zone at Puaahala to its previous designation. In October 1972 the Commission voted to withdraw its petition contingent on a statement presented by the proposed developers.

The statement presented by the developers contained certain assurances. One such assurance concerned some kuleanas located within the boundaries of the Puaahala urban district. The developers assured the Commission that they were going to obtain ownership of these kuleanas.

My question is: does the Land Use Commission have any record showing that the developers at Puaahala have indeed gained title to the kuleanas in question? If the Land Use Commission does not have such information, will it make an effort to obtain the information?
