On July 9, 1996, Intervenor E Mau Na Ala Hele

("Intervenor - E Mau") filed its Motion to Declare the Petition

Still Defective; or in the Alternative; Portions of the Petition

Still Defective ("Motion"), pursuant to Hawai'i Administrative

Rules ("HAR") Sections 15-15-70, and Hawai'i Revised Statutes

("HRS") Chapter 6E, and Section 205-4.

The Motion requested that the Land Use Commission

("Commission") issue an order removing the boundary amendment

petition filed by the County of Hawaii Planning Department

("Petitioner") in this docket from consideration by the

Commission on the grounds that the petition was still defective.

The Motion represented that the petition filed, as amended, remains defective pursuant to the petition requirements

listed in HAR Section 15-15-50(c). Specifically, the Motion cites HAR Section 15-15-50(c)(10), as the petition requirement that is not met by the petition filed, as amended.

The Motion also argues that until such time that an adequate archaeological inventory study is completed for all parcels within the petition area, the petition be deemed defective and processing of the petition be deferred.

On August 13, 1996, Intervenor - E Mau filed its
Supplemental Memorandum in Support of E Mau Na Ala Hele's Motion
to Declare the Petition Still Defective. The Supplemental
Memorandum further argued that the Petitioner was not in
compliance with HRS Section 6E-8, and that the requisite HRS
Section 6E-42 review by the State Historic Preservation Division
recommends deferral of a decision on the petition.

On August 21, 1996, Petitioner County of Hawaii
Planning Department ("Petitioner") filed its Memorandum in
Opposition to Intervenor E Mau Na Ala Hele's Motion to Declare
Petition Still Defective.

On August 22, 1996, the Motion came before the Commission at its meeting in Honolulu, Oahu. Upon hearing oral arguments by the parties, the Commission deferred action on the Motion due to Petitioner County of Hawaii Planning Department's HRS 6E appeal of the non-concurrence letter from the State Historic Preservation Division, Department of Land and Natural Resources, to the State Historic Preservation Board.

On December 2, 1997, the Commission held a continued action meeting on the Motion in Kailua-Kona, Hawai'i.

The Commission, having considered the arguments, both written and oral, provided by the parties in the subject docket, and upon review of the entire record herein, and good cause showing therefrom,

IT IS HEREBY ORDERED that the Motion to Declare the Petition Still Defective; or in the Alternative; Portions Still Defective filed by Intervenor E Mau Na Ala Hele IS HEREBY DENIED.
