On August 15, 2001, Petitioner filed PETITIONER LANIHAU PARTNERS L.P.'S MOTION TO AMEND PETITION FOR LAND USE DISTRICT BOUNDARY AMENDMENT; VERIFICATION; EXHIBITS "11" & "12"; and CERTIFICATE OF SERVICE ("Petitioner's Motion"), to request the Commission to authorize the change of name of the Petitioner from Lanihau Partners L.P. to Lanihau Properties, LLC (pursuant to Sections 15-15-43 and 15-15-70, Hawaii Administrative Rules ("HAR")).

ORDER




