ORDER DENYING PETITIONER'S MOTION FOR RECONSIDERATION FILED ON MAY 10, 2006

On May 9, 2006, the Land Use Commission ("LUC") issued its Findings of Fact, Conclusions of Law, and Decision and Order Denying Petition for a State Land Use District Boundary Amendment.

On May 10, 2006, James W. McCully and Francine M. McCully ("Petitioner") filed its Motion for Reconsideration and Memorandum in Support of Motion for Reconsideration.

On May 15, 2006, the Office of Planning, State of Hawai'i ("OP") filed its

Statement of No Position to Petitioner's Motion for Reconsideration dated May 10, 2006.

On May 22, 2006, the County of Hawai`i Planning Department ("County") filed its Statement of No Position on Petitioner's Motion for Reconsideration dated May 10, 2006.

On June 2, 2006, Petitioner filed its Supplemental Memorandum in Support of Motion for Reconsideration.

On June 6, 2006, the LUC conducted a meeting in Kailua-Kona, Hawai'i to consider Petitioner's Motion for Reconsideration. In attendance were Petitioner, the County, and the OP. No individuals provided public testimony.

The Petitioner stood by its position. The County noted that it continues to support the reclassification of the Petition Area because the County believes that Petition meets the standards for reclassification. The OP noted that it continues to support the reclassification of the Petition Area given the efforts made by the parties to stipulate to the facts of the Petition.

At its meeting on June 6, 2006, after deliberation by the Commissioners, a motion to deny Petitioner's Motion for Reconsideration was made and seconded. There being a vote tally of seven ayes, one nay, and one absent, the motion carried, having received the affirmative votes required by Section 15-15-13, HAR.

ORDER

IT IS HEREBY ORDERED that Petitioner's Motion for

Reconsideration filed on May 10, 2006 is DENIED.
