ORDER REGARDING PETITIONER'S VOLUNTARY PREPARATION OF A SUPPLEMENTAL ENVIRONMENTAL IMPACT STATEMENT

WHEREAS, the Land Use Commission ("Commission") considered

this matter at its meeting on February 1, 2007, in Honolulu, Hawai'i,¹ with R. Ben

¹ The Commission previously held meetings on this matter on December 8, 2006; January 4 and 5, 2007; and January 18, 2007. WHEREAS, at the meeting, the Commission acknowledged receipt of a letter from Petitioner to this Commission dated January 30, 2007, which stated, among other things, that Petitioner agreed with the Commission members' belief that an SEIS would provide the community with a better understanding of what is currently being developed on the Petition Area and would ensure that the

² On October 13, 2006, Petitioner filed a Petition For Land Use District Boundary Amendment ("Petition") to reclassify approximately 1,418.739 acres of land from the State Land Use Agricultural District to the State Land Use Rural District and approximately 16.016 acres of land from the State Land Use Agricultural District to the State Land Use Conservation District at Honua`ino 3 and 4, Hōkūkano 1 and 2, Kanāueue 1 and 2, Haleki`i, Ke'eke'e, `Ilikahi, Kanakau, Kalukalu, and Onouli 1, North and South Kona, Hawai`i ("Petition Area"), for the Hōkūli`a development. Hōkūli`a is an existing development that currently includes 338 subdivided lots, an 18-hole golf course with related improvements (golf shop, restaurant pavilion, and temporary maintenance facility), internal roadways, the initial segment of the regional Bypass Highway, the first phase of a shoreline park (the park is not located within the Petition Area as it is on adjoining lands within the State Land Use Conservation District; a 16.016-acre portion of the Petition Area that is adjacent to the park will be included as part of the park lands), buffers around cultural sites, and various utility infrastructure to serve the golf course, the lots, and the shoreline park. Individual lot owners have also completed three residences; an additional residence is presently under construction.

Included with the Petition was a Final Environmental Impact Statement ("FEIS") that was accepted by the County of Hawai'i Planning Director in September 1993 for Petitioner's then proposed Hōkūli'a development. Given the time that has passed since the acceptance of the FEIS, an issue was raised as to whether a Supplemental Environmental Impact Statement ("SEIS") is warranted for the current reclassification of the Petition Area for the development of Hōkūli'a, pursuant to chapter 343, Hawai'i Revised Statutes ("HRS"). The State Office of Environmental Quality Control has stated that this Commission, in coordination with the County of Hawai'i Planning Department ("Planning Department"), shall be responsible for determining whether an SEIS is required in this matter.

Commission's decision on the Petition is based on full consideration of the impacts from the proposed rural district reclassification;

WHEREAS, upon questioning, Petitioner confirmed its intention to voluntarily prepare an SEIS in this matter for review and acceptance by this Commission;

WHEREAS, the Planning Department and OP stated that given Petitioner's willingness to voluntarily prepare an SEIS, they have no objections to the preparation of an SEIS in this matter; now, therefore,

IT IS HEREBY ORDERED that a determination as to whether an SEIS is warranted pursuant to chapter 343, HRS, is rendered MOOT;

IT IS FURTHER ORDERED that Petitioner shall make an SEIS
Preparation Notice available for a 30-day public review and comment period
pursuant to section 11-200-15(b), HAR, and section 343-5(c), HRS; and

IT IS FURTHER ORDERED that a hearing on the Petition shall not commence until a final SEIS is accepted by this Commission and all the petition content requirements have been satisfied pursuant to section 15-15-50, HAR.
