ORDER DETERMINING (1) THAT THE LAND USE COMMISSION
AGREES TO BE THE ACCEPTING AUTHORITY PURSUANT TO CHAPTER 343,
HAWAI'I REVISED STATUTES; AND (2) THAT THE PROPOSED ACTION MAY
HAVE A SIGNIFICANT EFFECT UPON THE ENVIRONMENT TO WARRANT THE
PREPARATION OF AN ENVIRONMENTAL IMPACT STATEMENT

On November 28, 2007, Hawaiian Memorial Life Plan, Ltd., a Hawai'i Corporation ("Petitioner"), filed a Petition For Land Use District Boundary Amendment ("Petition") to reclassify approximately 56.6 acres of land at Kāne'ohe, Ko'olaupoko, O'ahu, Hawai'i, identified as Tax Map Key: 4-5-33: por. 1, from the State Land Use Conservation District to the State Land Use Urban District for cemetery expansion and

residential uses ("Project"). An Environmental Impact Statement Preparation Notice ("EISPN") was included with the Petition.¹

The Project is subject to the environmental review process as it proposes the reclassification of lands located within the State Land Use Conservation District pursuant to section 343-5(a)(7), Hawai'i Revised Statutes ("HRS"), and section 11-200-6(b)(1)(F), Hawai'i Administrative Rules ("HAR"), and involves an amendment to the Ko'olaupoko Sustainable Communities Plan pursuant to section 343-5(a)(6), HRS, and section 11-200-6(b)(2)(A), HAR.

On December 13, 2007, the Land Use Commission ("Commission") held a meeting in Honolulu, Hawai'i, to determine (i) whether this Commission should be the accepting authority pursuant to chapter 343, HRS; and (ii) whether the Project may have a significant effect upon the environment to warrant the preparation of an EIS pursuant to chapter 343, HRS. William W. L. Yuen, Esq., and Rachael Edinger appeared on behalf of Petitioner. Randy Hara and Mike Watkins appeared on behalf of the City and County of Honolulu Department of Planning and Permitting ("DPP"). Bryan C. Yee, Esq., and Scott Derrickson appeared on behalf of the State Office of Planning ("OP").

At the meeting, the Commission heard public testimony from the following individuals: Bettye Jo Harris, Daisy Payton, and Laura Morgenstein on behalf

¹ By preparing the EISPN, Petitioner has already acknowledged that the Project may have a significant effect upon the environment, and therefore will require the preparation of an Environmental Impact Statement ("EIS"). The EISPN contains an analysis of the significance criteria in relation to the Project as required by section 11-200-10, HAR, for an environmental assessment.

of herself and on behalf of Jack Gillmar. Upon completion of the public testimony, Petitioner proceeded with its presentation. Petitioner noted that the Project may have a significant effect upon the environment to warrant the preparation of an EIS. Petitioner also noted that as the filing of the Petition is the earliest practicable time to determine whether an EIS is required, this Commission should be the accepting authority for the EIS pursuant to chapter 343, HRS.

The DPP had no comments to offer on this matter. The OP stated that they supported the preparation of an EIS for the Project.

Following discussion, a motion was made and seconded to have this

Commission agree to be the accepting authority pursuant to chapter 343, HRS, and to

have the Commission find that the Project may have a significant effect upon the

environment sufficient to warrant the preparation of an EIS. There being a vote tally of


7 ayes and 2 absent, the motion carried.

ORDER

This Commission, having duly considered Petitioner's EISPN, the arguments by the parties in this proceeding, and a motion having been made at its meeting on December 13, 2007, in Honolulu, Hawai`i, and the motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause for the motion,

HEREBY ORDERS that it agrees to be the accepting authority pursuant to chapter 343, HRS, and that the Project may have a significant effect upon the environment to warrant the preparation of an EIS.

IT IS FURTHER ORDERED that Petitioner shall make the EISPN available for a 30-day public review and comment period pursuant to section 11-200-15(b), HAR, and section 343-5(c), HRS.



ORDER

IT IS HEREBY ORDERED that the LUC: 1) agrees to be the accepting authority of Petitioner's EISPN and EIS under chapter 343, HRS, and 2) determines that the proposed action in LUC Docket No. A07-777 warrants the preparation of an EIS pursuant to chapter 343, HRS, by the authority of the presiding officer under section 15-15-60, HAR.
