On September 3, 1996, the Office of Planning ("Petitioner"), formally known as the Office of State Planning, filed a Motion to Withdraw Petition Without Prejudice ("Motion") in this proceeding, pursuant to sections 15-15-34, 15-15-70, 15-15-76, Hawai'i Administrative Rules, and section 205-4, Hawai'i Revised Statutes.

The Land Use Commission, having duly considered Petitioner's Motion at its meeting on September 12, 1996, in Honolulu, Hawai'i, and having received no objections from the other parties to this proceeding, and good cause existing,

NOW HEREBY ORDERS that Petitioner's Motion filed in this docket be GRANTED.

IT IS FURTHER ORDERED that Petitioner shall not be subject to the requirements of section 15-15-76, Hawai'i Administrative Rules, and that Petitioner may file a land use district boundary amendment petition involving portions of the

same land that were before this Commission in this docket within one year of the date of the Order Granting Petitioner's Motion to Withdraw Petition Without Prejudice.

IT IS FURTHER ORDERED that the property which is the subject of this docket shall remain in the State Land Use Agricultural District.


