Gentlemen:

Pursuant to your letter of August 31, 1970 regarding the above subject, this is to advise that the Land Use Commission, at its meeting on September 26, 1970, declared that the special permit granted Helen Divine (SP69-60) on January 17, 1969 to construct an apartment building, restaurant-bar and shopping facilities at Kau, Hawaii, Tax Map Key 9-2-92: parcel 1, automatically expired due to her failure to comply with the conditions set forth by the Hawaii Planning Commission, i.e., construction to begin within one year from date of approval by the Land Use Commission (January 17, 1969) and construction to be completed within 12 months from the starting date.

Please be advised that my violation of the conditions imposed by the county or the Land Use Commission on any special permit will automatically void it. If this occurs, the County Planning Department may notify the applicant accordingly without a declaratory ruling by the Land Use Commission.
