Dear Mr. Orodener,

We'd like to submit one more item of concern to our summary.

Mr. Waring's August 10th, 2022 letter to Chair Giovanni states that Service Corporation International (SCI) "have committed \$25,000,000 for the development, grading and infrastructure."

However, in the LUC's October 13th 2020 *Finding of Fact, Conclusions of Law, and Decision and Order, Finding of Fact*; Finding of Fact #334 states "SCI will contribute the \$30 million in development costs".

SCI's \$25 million commitment is 16.6% short of the required \$30 million funding.

Thank you again for allowing us the opportunity to participate in the process.
