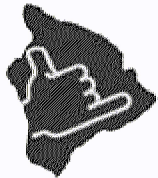

As a courtesy notice, on July 7, 2022, the Windward Planning Commission had approved the Special Permit request by Yamada & Sons, Inc. (PL-SPP-2022-000012). The request was to allow the establishment of a quarry operation and related improvements and activities on a 37.882-acre portion of a larger 2,407-acre parcel. The submission of the record will be forthcoming to the State Land Use Commission for final determination. So far, the record consists of approximately 850 pages.

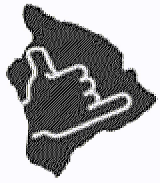

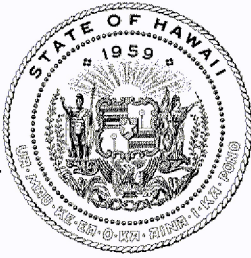
