Consider re-scheduling this meeting in Kona. It is commendable that the meeting is being held on Hawai'i Island. However, the meeting is a 2-hour drive away from the project location, and no remote testimony is allowed, creating a tremendous barrier to input from the people most affected.

Be cautious of going along with another "zombie project" that has not fulfilled conditions almost 20 years after approval.

Explore and address the concerns of those who say the area should not be developed at all because of the numerous historic sites. At a minimum, ensure strong protection for the three known burial sites, the heiau, the Kuakini Wall, and the historic trail.

Evaluate whether there will be sufficient water for the project, given the periodic water emergencies in Kona. Consider requiring low-flow water devices installed under an energy-saving performance contract. This would cut down the amount of fresh water needed, and reduce wastewater.

Evaluate whether the Kealakehe Wastewater Treatment Plant can handle sewage from the project, in light of the U.S. Supreme Court decision on the Hawai'i Wildlife lawsuit re. the Lahaina Wastewater Reclamation Facility in April 2020, and Judge Mollway's decision in July 2021 on the matter. Consider requiring a package sewage treatment plant and water recycling.

Address concerns about a large gathering center with bright lights that may affect birds and are bothersome to neighbors.

Address concerns about large numbers of students crowding shorelines and changing the face of the community.
