- Proposed findings shall be filed by Petitioner with the State of Hawai‘i Land Use Commission (“**LUC**”) by **December 30, 2022**.
- Comments, if any, on the proposed findings of fact, conclusions of law and decision and order shall be filed by the County and OPSD with the LUC by **January 13, 2023**.
- Responses to any such comments by Petitioner shall be filed with the LUC by **January 15, 2023**.
