The Land Use Commission received no written testimonies from the public on this matter. Chair Giovanni opened the meeting up for testimony on the Motion to Approve Job Credits for A89-651 Haseko (Ewa), Inc. There were three members of the public who wished to testify on this matter.

Mark Bowman, Fid Limani, and Mary Freeman provided public testimony in support of the Motion to Approve of Job Credits.

Mr.Tabata asked for the following submissions be admitted: Petitioner Exhibits 1-7, along with the Motion and the amended Certificate of Service, the OPSD and City and County responses, and the LUC Staff Report. There were no objections from the Parties, The Land Use Commission accepted the Exhibits listed as part of the Record.

Mr. Tabata gave a brief introduction and introduced his witnesses Daniel Lum and Lisa Enanoria.

Daniel Lum addressed the calculations of the job credits and gave a brief description of the master plan of the Project. In response to the Witnesses presentation, the Commissioners asked questions relating to housing, the calculations of man hours and man years involved, how the Petitioner came up with the methodology, and the availability of the raw data involved with the calculations (*YouTube*: 00:40:33).

Lisa Enanoria provided an overview of the outreach and participation in the community surrounding the Project area. In response to the Witness presentation, the Commissioners asked questions relating to the job availability, community support, infrastructure and water use, planning for climate change, and the Projects estimated timeline(*YouTube*: 01:12:43).

Raymond Kanna answered Commissioners questions on the infrastructure and tourism (*YouTube*: 01:17:30).

The Petitioner witnesses were followed by the presentation from the City and County of Honolulu. John Dubiel stated the City and County of Honolulu supports the Petitioners Motion, and introduced the discussion of freezing the amount of job credits for the 1990-2020 time period (*YouTube:* 01:38:20).

The City and County of Honolulu was followed by OPSD, which supports the Petition. Commissioners asked questions pertaining to the position on freezing the credits for the time period, annual reports and job credit reporting (*YouTube: 01:43:18*).

The Petitioner opposed freezing the job credits for the 1990- 2020 time but will have the burden of proving that credits are not being duplicated in future motions (*YouTube: 01:51:10*).

Public Testimony (YouTube: 01:57:44)

Once again, Chair Giovanni opened the meeting up for public testimony on the Petition for the Motion to Approve Job Credits for A89-651 Haseko (Ewa), Inc. There were no members of the public who wished to testify on this matter.
