# ORDER GRANTING APPLICANT'S MOTION TO WAIVE FEES AND EXPENSES AND TO EXCUSE APPLICATION FROM ANY REQUIREMENT TO REIMBURSE FEES AND EXPENSES

On April 14, 2008, the City and County of Honolulu Department of Environmental Services ("Applicant") filed a Motion to Waive Fees and Expenses and to Excuse Application from any Requirement to Reimburse Fees and Expenses ("Motion"), pursuant to sections 15-15-49 and 15-15-70, Hawai'i Administrative Rules ("HAR"). A Memorandum in Support of Motion ("Memorandum") was attached to the Motion.

In the Memorandum, the Applicant stated, among other things, that under section 15-15-49(a), HAR, the application fee for district boundary amendments is waived for state or county departments or agencies and argued that they should similarly be waived in this matter for the same policy reasons. The Applicant further noted that it initiated the proceeding to extend the deadline to accept solid waste at the Waimānalo Gulch Sanitary Landfill ("WGSL") until May 2010, or until the WGSL reaches its permitted capacity, whichever occurs first, for the benefit of the public and not for any private benefit or profit.


The Land Use Commission ("LUC") considered the Applicant's Motion at its meeting on April 24, 2008, in Honolulu, Hawai'i. Paul Herran, Esq., appeared on behalf of the Applicant. Bryan C. Yee, Esq., counsel to the State Office of Planning ("OP"), testified that OP had no comments on the Motion. At the meeting, the Applicant reiterated that it is a public agency and its application to extend the time to accept waste at the WGSL was filed for a public purpose. The Applicant clarified that the fees and expenses referenced herein pertains to the LUC's February 21 and March 6 and 7, 2008, meetings on the Applicant's application.

Thereafter, a motion was made and seconded to grant the Applicant's Motion. There being a vote of 8 ayes and 0 nays, and 1 absent, the motion carried.

#### ORDER

The LUC, having duly considered the Applicant's Motion, the oral arguments presented by the Applicant, and a motion having been made at a meeting conducted on April 24, 2008, in Honolulu, Hawai'i, and the motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause for the motion,

HEREBY ORDERS that the Applicant's Motion be GRANTED with respect to the fees and expenses pertaining to the LUC's February 21 and March 6 and 7, 2008, meetings on the Applicant's application to extend the time to accept waste at the WGSL.
