# SUBJECT: KULANIHAKOI (FORMERLY KIHEI) HIGH SCHOOL TEMPORARY CERTIFICATES OF OCCUPANCY TMK: 2-2-002: 081

Thank you for your letter dated October 20, 2022, also emailed on November 18, 2022, asking the Department of Planning (Department) to "grant" temporary Certificates of Occupancy (TCOs) for the new Kulanihakoi High School. The letter provides two "short term commitments" of providing crossing guards at the roundabout crosswalk and providing buses or shuttles until an overpass (or underpass) is constructed.

We would like to call your attention to our prior correspondence, summarized below and attached hereto:

- March 23, 2020: Letter from Tracy Okumura, Department of Education (DOE), stating that "the design of the pedestrian overpass has already been started" and attaching a timeline that shows the overpass being constructed between mid-2022 through mid-2023. This letter requested the Department to approve five pending building permits.
- April 3, 2020: Letter to DOE's Janna Mihara, stating that the State Land Use Commission (LUC) and County Council (Council) both imposed conditions on the project's entitlements that require the overpass (or underpass) to be constructed, not just designed, and that the Department would look for the overpass (or underpass) to be

> completed and useable to find compliance with the LUC's and Council's conditions requiring the overpass (or underpass). This letter asked for the DOE's commitment to complete the overpass (or underpass) before occupancy, in which case the Department could conditionally approve the building permits. This letter also stated "Please note that we will withhold approval of any Certificate of Occupancy until the overpass (or underpass) is constructed and useable."

- April 14, 2020: Letter from DOE's Tracy Okumura stating DOE's "commitment to constructing the pedestrian overpass" and that DOE "will insure that it is ready for use when the high school opens for students."
- April 21, 2020: Email exchange with DOE's Janna Mihara where the Department says it will sign-off on the five pending building permits, and confirms that it will not sign-off "on Certificates of Occupancy until the overpass can be used."

Ms. Mihara asked if the Department would sign-off on COs prior to completion of the overpass.

The Department responded that it would assess the progress of the overpass at that time, and that it could consider signing-off on TCOs if the overpass construction appeared to be on schedule.

We note that these exchanges took place more than two years ago, and that the DOE has been aware of the LUC's and Council's conditions ever since the entitlements were granted in 2013. On March 23, 2020, DOE stated that design of an overpass was underway; however, earlier this year, DOE conducted outreach to get community input on whether an overpass or underpass was preferred at various locations, bringing into question whether design was really underway in 2020 (though we commend DOE for finally reaching out to the community). We have informed DOE and its consultants for more than two years that it needs to request amendments to its State and County entitlements if it wishes to open the school before an overpass (or underpass) is useable or substantially complete; DOE and its consultants have acknowledged this but we have not seen any progress toward this effort.

The "short term commitments" presented in your October 20, 2022 letter should be presented to the LUC and the Council as justification to (temporarily) amend your entitlement conditions. These commitments are not sufficient for the Department to find compliance in order to sign-off on TCOs.

Until the entitlement conditions are amended, or until the overpass (or underpass) is at least substantially complete, the Department cannot sign-off on TCOs. If DOE occupies the buildings before an overpass (or underpass) is built, DOE would be in violation of its State and County entitlements.





Thank you for your letter dated March 23, 2020, asking the Department of Planning (Department) to approve several building permit applications for the new Kihei High School.

Your letter states that "HIDOE is committed to moving forward with the design of the pedestrian overpass" and provides a project timeline for the overpass and the remaining school structures. However, the specific language of the conditions of approval of the project by the State Land Use Commission and the Maui County Council call for the overpass (or underpass) to be <u>constructed</u> not just designed. For the Department to find compliance with these conditions, the overpass (or underpass) must be completed and useable before or at the same time that the school buildings are ready for occupancy.

If you can provide us with a letter that documents your commitment to constructing the overpass (or underpass) and having it ready for use before or when the buildings are ready for occupancy, then we can conditionally approve the building permits. Please note that we will withhold approval of any Certificate of Occupancy until the overpass (or underpass) is constructed and useable.

We note that the project timeline includes an Environmental Assessment (EA) for the overpass (or underpass); we believe that this may not be needed since this component was a condition of approval after the environmental review process was completed. However, if an EA will assist – through its analysis of alternatives – with obtaining community input and providing disclosure of the issues related to both an overpass and an underpass, then such a process would be worthwhile. In other words, we believe that the South Maui community strongly supports an underpass rather than an overpass, and an EA would be a valuable mechanism for you to consider both options.

The Hawaii State Department of Education (Department) requests the support of the County of Maui, Department of Planning in seeking the approval of County of Maui agencies to grant temporary Certificates of Occupancy (COs) for the school buildings on the new Kulanihakoi High School campus. These temporary COs would allow the school to open on its new campus at the beginning of January 2023 or soon thereafter with the following short term commitments in place:

- The Department and the Hawaii State Department of Transportation (DOT) are committed to arranging for a Maui Police Department officer or crossing guard at the roundabout crosswalk in the morning and afternoon hours when school is in session until such time as a Grade Separated Pedestrian Crossing (GSPC) is operational, or the County, the Department, and DOT all agree the service is no longer needed.
- The Department is committed to providing bussing/shuttling to and from the school from a satellite location(s) in the morning and afternoon when school is in session until such time as a GSPC is operational, or the County, the Department, and DOT all agree the services are no longer necessary.
- The Department and DOT are committed to the construction of a GSPC overpass, located near Kulanihakoi Street. Start of construction will be subject to funding.

Hi again Janna,

We can assess the situation when the time comes. To be frank, DOE does not have a good track record on this matter.

The community clearly wants an underpass, yet DOE is pursuing an overpass. The County and LUC conditions of approval call for either an overpass or underpass, but DOE tried to get around the requirement by having DOT say it wasn't warranted. It falls on the Planning Department to ensure that the County and LUC conditions are met, so we had to go back to the LUC to get this clarified.

When the time comes, please get in touch with me, and my Department will assess the progress on the overpass (or underpass) at that time. If it appears to be on schedule and that DOE has proceeded in good faith, then we may sign-off on Temporary COs to allow you to move-in and set-up.

Aloha Michele, Great news. The DOE appreciates your department's support for this project.

In regards to your comment on the certificate of occupancy, we would greatly appreciate it if you would consider signing-off on the certificate of occupancy at least 6 months prior to the completion and use of the pedestrian overpass to prevent any delays in opening the school. When we have started new schools in the past, the Administration (including key cafeteria, library, and teaching staff) have typically asked for 5-6 months to move in and set-up operations prior to officially opening the school and accepting students. I have attached a list of some of the kinds of tasks the school needs to work on once they move into the school facility, but prior to opening.
