pending CBESS Board approval.

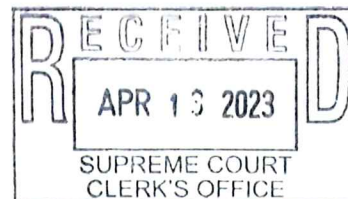
_____ The parties partially settled or narrowed issues, but were unable to resolve the
