#### Public Testimony (YouTube: 00:16:39)

The Land Use Commission received no written testimony from the public on this matter.

Chair Giovanni opened the meeting up for testimony on the matter, and there were no members of the public who wished to testify on this matter.

#### **Presentations** (YouTube: 00:11:14)

Ms. Chow commented and elaborated on the Stipulated Agreement for Remand. The remand would allow the opportunity to supplement and add additional information to the record.

After Linda Chows' comments, Alison Kato Deputy Attorney General for The Office of Planning and Sustainable Development ("OPSD"), commented in support of the Stipulated Agreement for Remand.

Commissioner Okuda questioned the Petitioner on the cogent information being added to the record and the scope of the Special Permit being sought. One of the issues that Okuda brought up was Chapter 343, correctional facilities and rehabilitation planning, the Hawai'i Correctional System Oversight Commission, and the social impacts involved with the correctional system. Okuda also asked to include the discussion of district boundary amendment vs special permit and the limitations of the special permit to be included in the remanded record (*YouTube: 00:13:55-00:27:38*).

Once again, Chair Giovanni opened the meeting up for testimony on the matter, and there were no members of the public who wished to testify on this matter.

## **Deliberations** (YouTube: 00:28:30)

Commissioner Ohigashi moved for the matter be remanded to the Honolulu Planning Commission under the terms of the stipulated agreement with the parties. Commissioner Okuda seconded. The Motion passed with 7 ayes, 0 nays, and 2 excused.
