

We believe that there are cogent and relevant information and evidence that should be put in and considered by the Land Use Commission that was not put in below, and so we would like the opportunity to supplement the record with that information and to bring it back to the Land Use Commission.

CHAIRMAN GIOVANNI: So if I understand
correctly, you want to go back to the -- you intend
to go back to the Planning Commission and supplement

We believe that it would be good for petitioner to 17 18 provide more for the record to give a better 19 presentation to you. 20 CHAIRMAN GIOVANNI: So is OPSD a party to 21 the stipulated agreement? 22 MS. KATO: Yes. 23 CHAIRMAN GIOVANNI: Very good. 24 Any questions, commissioners, for the 25 petitioner or any of the parties?



Commissioner Okuda.
 COMMISSIONER OKUDA: Thank you, Mr. Chair.
 This is Gary Okuda.

Let me frame my questions so that you see where we're going and, you know, this is not to trap anyone or anything like that. And this goes to the issue or the matter about the cogent information which will be supplemented or intended to be supplemented.

10 There's two areas I wanted to ask you 11 about as far as supplementation. One is the scope 12 of a special permit and the information which you 13 might consider in supplementing the record. And the 14 second area is whether or not the record as it 15 stands now needs to be supplemented with cogent 16 information required by Chapter 343.

So let me take the second element first 17 18 and go over that. Now, I'm only going to ask the 19 questions. It's up to you folks whether you think 20 this type of information needs to be presented or 21 not presented. The reason why I'm raising it is 22 just so that if and when this matter comes back 23 before us, it won't be a surprise or it won't look 24 like an ambush. Because I don't think, you know, we 25 -- we accomplish anything by trying to ambush

anybody, so I'm trying to show you what, at least, 1 2 just my concerns are. I don't speak for anyone 3 else, okay? But taking first the issue of a Chapter 4 5 343 compliance. Chapter 343, as we know, deals with 6 environmental assessments, environmental impact 7 statements, correct? 8 MS. CHOW: Correct. COMMISSIONER OKUDA: Okay. Let me read 9 10 you a sentence from this Hawaii Supreme Court case, 11 Sierra Club versus Department of Transportation, 12 found at 115 Haw. 239. What I'm going to read is a 13 sentence found at page 306. The P.3d citation is 14 167 P.3d 292, at page 299. That's a 2007 Hawaii 15 Supreme Court case. And the case is better known or known by other people as the "Superferry" case. 16 17 And this is what the Supreme Court ruled 18 at that location in the case, and I quote, "The law 19 requires that government give systematic 20 consideration to the environmental, social, and 21 economic consequences of proposed development 22 projects prior to allowing construction to begin," 23 close quote. 24 Is that an accurate statement of the law? 25 I believe it is. MS. CHOW:

COMMISSIONER OKUDA: Okay. Do you folks 1 2 agree that prisons and, in fact, the type of prison 3 can have social impacts? 4 MS. CHOW: Yes, we do. 5 COMMISSIONER OKUDA: Okay. And along this 6 line, the Hawaii Legislature created a commission 7 called The Hawaii Correctional System Oversight Commission to Help Guide Hawaii's Policies Regarding 8 9 Prisons, isn't that correct? 10 MS. CHOW: I -- I'm not sure. I don't --11 I've not been advising Public Safety Department, but 12 13 COMMISSIONER OKUDA: Yeah. Well, that's fair. Let me just tell you where you might want to 14 15 look --16 Sure. MS. CHOW: 17 COMMISSIONER OKUDA: -- at, and again, I'm 18 not saying that my view of the law or what I'm going 19 over is correct or not. This is just to give you a 20 heads-up on something to look at. You make the 21 independent decision whether you believe these 22 matters require supplementation or not. You know, 23 it may not require supplementation, and it might not 24 have any outcome on the ultimate outcome. 25 But please look at HRS Section 353L-3,

1	which sets forth the duties, the powers of the
2	Hawaii Correctional System Oversight Commission.
3	And what it says in 353L-3(b)(1), it says, "The
4	commission shall," and it's (1), "oversee the
5	State's correctional system and have jurisdiction
6	over investigating complaints at correctional
7	facilities and facilitating a correctional system
8	transition to a rehabilitative and therapeutic
9	model." And then the statute continues on regarding
10	other duties of the commission.
11	And this commission consists, correct, of
12	five commissioners, right? Well, anyway, take a
13	look at the statute because the five commissioners,
14	one is appointed from each of the following entities
15	or people. For example, the Office of Hawaiian
16	Affairs selects one commissioner, the Speaker of the
17	House selects another commission, the President of
18	the Senate selects another commissioner, the
19	Governor selects another commissioner, and the Chief
20	Justice selects the final commissioner.

Do you have any idea or knowledge of why the Office of Hawaiian Affairs selects a commissioner on this commission? Because, for example, like us on the Land Use Commission, I don't think the Office of Hawaiian Affairs



1	automatically selects anyone, you know, on the
2	commission.
3	Do you have any idea or understanding of
4	why the Office of Hawaiian Affairs would select a
5	commissioner?
6	MS. CHOW: No, I do not.
7	COMMISSIONER OKUDA: Okay. But you might
8	look at who's appointed to the commission right now,
9	five individuals. They seem actually really
10	experienced in the area of corrections and prisons.
11	And I wouldn't take any of these people as being
12	people who are like, oh, wow, we really don't need
13	any prisons at all.
14	I mean, one of the people on the
15	commission is retired Judge Ronald Ibarra, who I
16	believe when he was Chief Judge of the Third
17	Circuit, which covered the County of Hawaii, he set
18	up the Veteran's Court, the Drug Court. I know I'm
19	not testifying here, but my recollection of being
20	in his courtroom is he's a law-and-order kind of
21	guy.
22	You had you have Retired Judge Michael
23	Town. You have a couple former prison
24	administrators. So these people seem to have a lot
25	of, you know, knowledge and information about, you

1 know, about prisons.

Is there anything in the record right now 2 3 which indicates the input of the Hawaii Correctional System Oversight Commission was included in any of 4 5 the 343 HRS chapter assessments or reviews? Did 6 they weigh in on anything dealing with the Waiawa 7 Correctional Facility or anything related to the 8 special permit that is brought before us today, which is going to be remanded? 9

MS. CHOW: In my review of the record, I did not see anything from that commission.

12 COMMISSIONER OKUDA: Okay. And my only 13 suggestion is this: if you will, you know, consider 14 what I hope is just a humble request, that you look 15 at whether or not input from the Hawaii Correctional 16 System Oversight Commission might be relevant in 17 this case to determine social impacts.

18 Now, again, you know, I've never really 19 practiced criminal law, so I'm definitely not an 20 expert in that, but that's the reason why we have a 21 343 HRS chapter review whether it's an environmental 22 assessment or an environmental impact statement, so 23 that we will have the information to determine what 24 might be the social impacts of the government 25 decision here.

1	And let me tell you one of my concerns of
2	why I personally would like input from the Hawaii
3	Correctional System Oversight Commission, and it's
4	because of the I want to make sure that whatever
5	we do or whatever I vote is consistent with what the
6	commission and other experts, in addition to the
7	commission, believe should be the the outlook or
8	the goal of the prison system here.
9	And again, I'm not the expert, so that's
10	why we rely on the Chapter 343 reports and
11	submissions. But one of the things that concerns me
12	is a report that I found on the United States
13	Department of Justice list of studies and reports.
14	And just so that the record is clear here,

And just so that the record is clear here, let me just quote a very short sentence. It's actually a run-on sentence, but it summarizes this report called Disparate Treatment of Native Hawaiians in the Criminal Justice System. And the NCJ number is 242614. The date that the report was published is 2010, and it consists of 104 pages.

Now, I'm not going to read all the 104 pages of submitted in the record. I'm just raising this so that maybe you can see why -- at least just me personally, I would like to see input from the commission. But this is what, for example, the



1	abstract of that report says.
2	It says, and I quote, "Native Hawaiians
3	bear a disproportionate burden of punitive responses
4	to drug use; and Native Hawaiians do not use drugs
5	at a drastically different rate from other races or
6	ethnicities but go to prison for drug offenses more
7	often than people of other races or ethnicities; and
8	Native Hawaiians are charged with the majority of
9	offenses related to methamphetamine, but report
10	using this drug at only slightly higher rates than
11	people of other races or ethnicities."
12	So I'm not saying so again, to repeat
13	myself, you know, at least me personally, I would
14	like to see the record supplemented to be sure we
15	satisfy the requirements of Chapter 343, and that
16	social impacts, if anything, are addressed by the
17	record if and when it comes back up to us. And I
18	personally believe input from the commission, which,
19	as far as I can tell, consists of very, very
20	experienced people from who have been involved in
21	the criminal justice system, that that input be
22	included so we on the commission, who are not
23	experts in corrections or social impacts of the
24	correctional system, are fully educated. So please
25	consider my request, okay?

1	The second point about whether or not the
2	issue regarding special permits is addressed versus
3	district boundary amendment is please also have
4	addressed in the record whether or not a special
5	permit will in fact comply with what the Supreme
6	Court has laid out as far as limitations of the use
7	of the special permit, an example of what the
8	Supreme Court has said is this case called
9	Neighborhood Board Number 24 (Waianae Coast) versus
10	State Land Use Commission, which is found at 64 Haw.
11	265, and I'm sorry I don't have the Pacific Reporter
12	section, but that citation, but that's the
13	official reporter citation, which is a 1982 Hawaii
14	Supreme Court case which dealt with what we all know
15	as the Kapolei Waterpark.
16	So if the record, when it comes back up
17	here, if it does, makes clear why a special permit
18	is appropriate and satisfies the requirements of the
19	case I cited.
20	So Mr. Chair, that's basically my
21	commentary at this point in time. Thank you.
22	CHAIRMAN GIOVANNI: Thank you,
23	Commissioner Okuda. I think your points are on
24	point and to be well taken by petitioner as they
25	proceed back through the process before they return

1	here. So thank you, Commissioner Okuda.
2	MS. CHOW: Yes, thank you.
3	CHAIRMAN GIOVANNI: Commissioners, any
4	further comments or questions?
5	Okay. Given the circumstances, and in
6	accordance with our procedural process, I'm going to
7	ask again a second time if there's any public
8	testimony on this matter.
9	Ms. Kwan, is there anybody that would like
10	to give public testimony at this time?
11	MS. KWAN: No, Mr. Chair.
12	CHAIRMAN GIOVANNI: Thank you, Ms. Kwan.
13	Petitioner, any final comments you'd like
14	to make at this time?
15	MS. CHOW: Not at this time. Thank you.
16	CHAIRMAN GIOVANNI: Thank you.
17	Commissioners, what is your pleasure, with
18	the understanding that there's a stipulated
19	agreement to remand this petition. Is there a
20	motion to remand the petition back to the Honolulu
21	Planning Commission?
22	Commissioner Ohigashi?
23	COMMISSIONER OHIGASHI: I move to remand
24	this matter back to the Honolulu Planning Commission
25	under the terms of the stipulation that has been



filed by the parties. 1 2 CHAIRMAN GIOVANNI: Thank you, 3 Commissioner. Is there a second to the motion? 4 5 MR. OKUDA: Chair, I second the motion. 6 CHAIRMAN GIOVANNI: There's a motion that 7 has been moved by Commissioner Ohigashi and seconded 8 by Commissioner Okuda. 9 Commissioner Ohigashi, would you like to 10 speak to your motion? 11 **COMMISSIONER OHIGASHI:** No, because my 12 microphone -- I would echo Mr. Okuda's statements --13 Commissioner Okuda's statements. And I think that given -- given that it's one of my pet peeves about 14 15 special use permits, I would hope that the State of 16 the Hawaii agencies would really look at whether or 17 not they should determine whether this should be 18 done as a DBA. Thank you. 19 CHAIRMAN GIOVANNI: Thank you, 20 Commissioner Ohigashi. 21 Commissioner Okuda, would you like to 22 speak to your second? 23 COMMISSIONER OKUDA: This is Gary Okuda. 24 Thank you, Mr. Chair. I think my reasons and my 25 questions have already been laid out. I do believe



1	more input from and I hate to use the word
2	"stakeholders" because everyone in the community has
3	a stake in what the outcome is. But it also might
4	be helpful or relevant if the Office of Hawaiian
5	Affairs is consulted with what their view is because
6	this is more than just simply building a prison.
7	Okay?
8	And we're not talking about just simply
9	putting up a government building. This facility has
10	social impacts, and we need guidance here from
11	people who are have expertise in the area about
12	what the social impacts are. Easy to put up a
13	building; hard later to fix negative social
14	impacts.
15	So I would ask everyone to vote in favor
16	of remanding this and approving the stipulation.
17	Thank you.
18	CHAIRMAN GIOVANNI: Thank you,
19	Commissioner.
20	Commissioners, any other comments?
21	MS. CHOW: May I clarify?
22	CHAIRMAN GIOVANNI: Yes, please. The
23	Chair recognizes the petitioner.
24	MS. CHOW: Hi. Deputy Attorney General
25	Linda Chow again. And I just want to clarify that

1 this petition is not for the erection of any new
2 structures. This is only for an after-the-fact
3 permit for the existing facilities that are already
4 there.

5CHAIRMAN GIOVANNI: Thank you for the6clarification. I think the record reflects that.

MS. CHOW: Yes. Thank you.

8 CHAIRMAN GIOVANNI: Commissioners, further 9 comment?

11 **COMMISSIONER CABRAL:** Thank you. Ι 12 actually want to support the motion and 13 particularly thank Commissioner Okuda for his input in the fact that these are things that most of us 14 15 don't think about when a building goes up and when 16 the streets go in and the stop lights are there and 17 that, but it is clearly something that, as in the 18 big picture in a community, we need to put more 19 thought into.

And so I appreciate that this has come forward and absolutely support that recommendation so that maybe things could become different, and, you know, you add more acreage for -- to raise cattle or something good. Thank you. **CHAIRMAN GIOVANNI:** Thank you,



1 Commissioner Cabral.

The Chair will also support the motion; although, I also want to add my commentary behind that to Commissioner Ohigashi regarding the special use permit versus a DBA.

6 The trouble that we have as commissioners, 7 and it's come up recently and several times, is that 8 special use permits on agricultural land for developments that have permanence, as if this prison 9 10 is going to disappear at the end of a certain fixed 11 term, is troublesome to us. It just seems that when a development of agricultural land is as a never-12 13 ending cycle to it, it doesn't have a fixed term 14 that will return that land to agriculture; that a 15 DBA may be more appropriate.

So we ask you to take that to heart. And if you do come forward under the terms of the special permit, please have a good story for why it's not a DBA request.

20 So with that, I'll turn to Mr. Orodenker 21 to -- for a vote of the commission.

MR. ORODENKER: Thank you, Mr. Chair.
The motion is to remand this matter back
to the Honolulu Planning Commission under the terms
of the stipulation signed by the parties.

I would like 18 to also praise, I think, our commission and the 19 commission since I've been involved, and also the 20 staff for their preparation, the really what I think 21 is an excellent job on preparing our information and 22 trying to help make me look good even when I can't 23 hear and speak properly. So I want to thank 24 everybody, so -- you know, it's a real team effort, 25 and I appreciate the teamwork. Thank you.

1 CHAIRMAN GIOVANNI: Thank you, Commissioner Cabral. 2 3 Commissioners, any further -- anybody else 4 want to speak to this? 5 Commissioner Ohigashi. 6 COMMISSIONER OHIGASHI: Yeah. My comment 7 is simply this, is don't be surprised if I 8 (inaudible). Don't be surprised if I had the same 9 schedule (inaudible). 10 COMMISSIONER CABRAL: Mine's not here, so 11 12 CHAIRMAN GIOVANNI: My comment is one of sadness with the loss of our current Vice-Chair, 13 Nancy Cabral. 14 15 So Commissioner Cabral, I want to 16 acknowledge and thank you for serving as First Vice-17 Chair and for serving on this commission for several 18 years. 19 COMMISSIONER CABRAL: I'm not gone yet. Is there any 7 clarification on the annual increase for the unionized state workers? 8 9 Mr. Orodenker? 10 MR. ORODENKER: Short answer, no. 11 CHAIRMAN GIOVANNI: I expect we will have 12 clarification of that by our next meeting? 13 MR. ORODENKER: Yes. Yes. Where -- there are two sides to that coin. Number one is I'm not 14 15 sure I know exactly how much the negotiated 16 increases we'll be paying to our entire budget. Second of all, I'm unclear as to what the state 17 18 budget, which was just passed by the legislature, 19 contains with regards to that. 20 CHAIRMAN GIOVANNI: But you expect 21 clarification --22 MR. ORODENKER: Yes, we expect the work on 23 the budget to come out in about end of May. Yeah. 24 Two or three weeks. 25 CHAIRMAN GIOVANNI: So the Chair would



1 just like to state for the record that, you know, 2 the historical trends prior to the current year have 3 been relatively modest, as in -- as interest rates 4 were low and inflation rates were low. But there 5 has been a substantial change in that recognized by 6 everyone over the last 12 months.

7 So I am particularly interested in how the 8 State Legislature and the Governor's Office will 9 take that into account, and I look forward to those 10 clarifications.

11 MR. ORODENKER: Thank you, Mr. Chair. Before we adjourn, I would like to -- I 12 13 just realized that I may not have been in with everyone with regard to this, but there has been an 14 15 appointment approved by the Senate to replace 16 Commissioner Tan (phonetic), and that is Brian Lee 17 who currently serves on the Planning Commission and 18 sitting (inaudible).

He is a member or represents the unions, the Carpenter's Union, on various matters. And he will be joining us once he has extricated himself from the other commissions that he currently sits on. We're expecting him in the June meeting. **CHAIRMAN GIOVANNI:** Commissioner Ohigashi?

COMMISSIONER OHIGASHI: Can you give me 1 2 his email so that --3 MR. ORODENKER: Most certainly. 4 CHAIRMAN GIOVANNI: He is a little 5 confused, so --6 MR. ORODENKER: He's gone through our 7 advisor. He's been approved. 8 CHAIRMAN GIOVANNI: He's been approved, 9 but he cannot speak -- he cannot sit on the commission until he has extricated himself? What do 10 11 you mean by that, extricated? 12 MR. ORODENKER: State law is --13 CHAIRMAN GIOVANNI: Extricated? 14 MR. ORODENKER: Yeah, he's got to quit. 15 He's got to quit. 16 (Inaudible Crosstalk.) 17 MR. ORODENKER: We've got a plan to break 18 him out and -- no. 19 The way I understand State law with regard 20 to commissioners is that you can only serve on one 21 board or commission at a time. And so he was -- he 22 had resigned from the Planning Commission, and they 23 asked him to stay on because they had some things 24 that they had not finished when -- that they needed 25 him to complete with them, so he agreed to stay on

1	for an amount of months. Otherwise, he would have
2	been resigned and then at this meeting.
3	CHAIRMAN GIOVANNI: Okay. So he has
4	agreed to serve an additional month on Honolulu
5	Planning Commission, which is conflicted with
6	today's meeting, which is why he's not here.
7	MR. ORODENKER: That's correct.
8	CHAIRMAN GIOVANNI: But if the month if
9	he doesn't extend beyond the current month, he will
10	have cleared up he will have effectively
11	extricated himself from everything he needs to
12	extricate himself from. He'll be here in June.
