#### Public Testimony (YouTube: 00:23:14)

The Land Use Commission received testimony from Ken Church, Office of Planning and Sustainable Development, Commission on Water Resource Management, Department of Agriculture, and the County of Hawai'i.

During the hearing Cal Chipchase provided testimony in person, and David Arakawa, Mary Alice Evans, and Zendo Kern provided testimony virtually.

Commissioners had the opportunity to question the testifiers questions included background information, written submission of testimony provided, explanation of disagreement, and an estimated timeline for which is needed to provide more in-depth testimony regarding the proposed rule amendments.

Dan Orodenker stated that most of the suggested amendments are non-substantial, or in response to Supreme Court cases. Mr. Orodenker also identified areas in the current draft of the rules that need editing in response to some of the public testimony received. Commissioners asked staff questions regarding separating the non-substantial edits and the substantial edits, frequency of rule changes and previous timeline, County comments and other public entity interaction, and how the edits regarding special permits were received from the Deputy Attorney General.
