Your application for a modification of the subject Special Use Permit (SUP) and Conditional Use Permit Major (CUP) is accepted for processing as of November 9, 2007. Please refer to file numbers 2007/SUP-6 and 2007/CUP-91 in future correspondence on your application.

Comments and recommendations will be requested from various public agencies, the Neighborhood Board, and the public. Additional information may need to be submitted, after their comments are received.

You will be informed of the Director's recommendation for the SUP to the Planning Commission, in writing, as soon as our review is completed. The Planning Commission will hold a public hearing for the proposed SUP modification. A public hearing notice will be placed in the Honolulu Star-Bulletin at least 30 calendar days before the hearing is held. Since the application is for modification of an SUP that exceeds 15 acres, a decision by the Planning Commission may be subject to review by the State Land Use Commission.

In addition, a separate public hearing on the proposed CUP (Major) Modification may be held by the DPP. You will be notified of the hearing date; public notice will also be placed in the Honolulu Star-Bulletin at least ten (10) days before the hearing is held.

You are required to send notice of the proposed use of the site, by regular mail, to the owners of all properties within 300 feet of the project's boundaries within ten (10) days of the date of this letter. We have enclosed a mailing list for your use in this effort. Please submit an affidavit confirming that the notification requirements have been met to our department two weeks prior to the public hearing date.

In addition, you must erect a "notice of pending permit" sign on the affected lot(s) no less than fourteen (14) days before the public hearing date for the CUP (Major) Modification. The sign shall be nine square feet in area and be posted along each street frontage of the lot in the required front yard. The sign shall be visible to the general public and must contain the following:

1. The words "Notice of pending land use permit application for (the name of the permit type)";
2. A summary description of the nature of the request covered by the application;
3. The name of the applicant or agent, and the address and phone number where the applicant or agent can be contacted;
4. The date, time and place of the public hearing.

You are not required to obtain a sign permit for this sign, but it must be removed no more than seven days after the public hearing has been closed.

Processing of the CUP will be contingent upon receiving an updated site plan drawn to scale showing existing and any proposed structures, including fences and walls, on-site traffic circulation patterns, details of parking areas including dimensions of parking stalls and maneuvering areas, details for each existing and proposed structures, including building heights, setbacks from property lines, street setbacks, if any, floor area and building area.

For your information, as the processing timeframe for the SUP exceeds that of the CUP, the Director's decision on the CUP may be held in abeyance until a decision on the SUP has been rendered.
