Aloha

We would like to provide public testimony in support of the Lāna'i – Affordable Housing Project. Ikaika Ohana has been engaged to provide a plan that meets all the requirements of the County of Maui 201H Zoning and the State of Hawaii Land Use Commission approvals as respects development of affordable housing residences on Lāna'i. To date, we have engaged our architect, civil engineer, and general contractor to develop conceptual plans for the development of 46 rent to own single-family homes for the Lāna'i workforce (each home will be situated on a 6,000 square foot lot) and an apartments community with 26 apartment homes for seniors. Both communities in phase 1 of this development will also have access to a community center and the developer will also construct a park as required under terms and conditions of the 201H Zoning approval. The developer has reviewed the State of Hawaii Land Use Commission's approval and will implement all requirements pursuant to this document as well. The project will include much needed wrap around service that will be available to the tenants and surrounding community. Further, the single-family homes will be available for purchase at the end of the 15-year tax credit compliance period.

Both projects will utilize Section 42 Low Income Housing Tax Credits in their capital stack with income and rent restriction up to 80% of the County of Maui's AMI.

Given the significant coordination between the County of Maui, the Department of Hawaiian Homelands, Pālama Lāna'i, and Ikaika Ohana the development has overcome the significant condition that have prevented the construction of the project in the past primarily the small scale and infrastructure hurdles.
