INTERVENOR SCHNITZER STEEL HAWAII CORP.'S MOTION FOR ENLARGEMENT OF TIME

Schnitzer Steel Hawaii Corp. ("Schnitzer"), by and through its attorneys, WATANABE

ING LLP, respectfully moves the Honolulu Planning Commission to approve Schnitzer's request

for an enlargement of time until Tuesday, June 13, 2023, for the filing of Schnitzer's Motion to Intervene. This request for an enlargement of time is being filed in an abundance of caution. Pursuant to the Notice of Public Hearing ("Notice") published in the Honolulu Star-Advertiser on Monday, May 29, 2023, "any person or agency wishing to intervene as a party in the proceeding shall file a petition with the Commission within fourteen (14) days after this notice is published in the Honolulu Star-Advertiser." Monday, June 12, 2023, Kamehameha Day, marked fourteen days from the Notice of Public Hearing. However, Rules of the Planning Commission ("Planning Commission Rules") §2-16 regarding computation of time provides as follows:

"In computing any period time under the rules herein, by notice, or by any order or rule of the commission, the time begins with the day following the act, event, or default, and includes the last day of the period unless it is a Saturday, Sunday, or legal Holiday in which event the period runs until the end of the next day which is not a Saturday, Sunday, or legal holiday. When the prescribed period of time is ten (10) calendar days or less, Saturdays, Sundays, or holidays within the designated period shall be excluded in the computation."

See Planning Commission Rule § 2-16. (Emphasis added).

Monday, June 12, 2023, Kamehameha Day was a State Holiday. Accordingly, pursuant to Planning Commission Rule § 2-16, the fourteen-day period runs until Tuesday, May 13, 2023. Schnitzer will be concurrently filing its Motion to Intervene on Tuesday, June 13, 2023 and therefore reiterates that this request has been brought out of an abundance of caution. For the foregoing reasons, Schnitzer respectfully requests that the Planning Commission grant an enlargement of time until June 13, 2023, for Schnitzer to file its Motion to Intervene if it deems Monday, June 12, 2023, to be the end of the fourteen-day filing period.
