### Public Testimony Round One (YouTube: 00:09:02 - 00:09:30)

The Land Use Commission received no written testimonies prior to the meeting on the Adoption of the Draft Findings of Facts, Conclusions of Law, and Decision and Order for Application to Modify SP09-403.

#### Presentations (YouTube: 00:09:35 -00:23:20)

ENV (*YouTube: 00:09:35 - 00:10:33*) had no comments on the adoption of the proposed decision and order. Commissioner Kahele asked a question of the Petitioner regarding the lifespan of Waimānalo Gulch Sanitary Landfill and the future of association of the PVT Landfill.

KOCA (*YouTube: 00:10:36 - 00:14:41*) suggested revision to pg. 68, to specify that the in person quarterly reporting requirement imposed by the City and County of Honolulu Planning Commission and further subject to quarterly reporting from the Applicant to the Land Use Commission in writing. There were no objections by the Parties.

Schnitzer Steel Hawai'i (*YouTube: 00:18:43 - 00:19:45*) supported the adoption of the proposed decision and order with the changes suggested by KOCA. There were no questions from the parties or Commissioners.

City and County Department of Planning and Permitting (*YouTube: 00:19:50 - 00:20:47*) had no objections as to the form of the proposed order. There were no questions from the parties or Commissioners.

OPSD (YouTube: 00:20:55 - 00:22:17) presented their support for the adoption of the proposed decision and order, with the amendments identified by KOCA. Additionally, OPSD identified two typographical errors (p.19 highlighted word and p.56 misspelling). There were no questions or objections from the parties.

#### Public Testimony Round Two (YouTube: 00:23:20 - 00:23:39)

Chair Giovanni invited public testimony on this matter, there were no individuals that wished to provide public testimony on the matter at this time.

Commissioner Carr Smith seconded the motion. The motion was approved with 6 ayes, 0 nays, 2 excused, and 1 recused.
