SUBJECT: Request for Extension of Time to Respond to Gentry Investment Properties' Motion for An Order, Filed January 24, 2025 with the State Land Use Commission

Pursuant to Hawai'i Administrative Rules (HAR), § 15-15-42(a)(1), the Department of Planning and Permitting, City and County of Honolulu ("DPP"), respectfully requests an extension for the DPP to file its response to Gentry Investment Properties' ("Petitioner") Motion for an Order filed on January 24, 2025 ("Motion") with the State Land Use Commission ("LUC"), for Docket No. A03-738. The Petitioner is seeking an order releasing conditions 1 through 22 in the Findings of Fact, Conclusions of Law, and Decision and Order dated and filed on January 2, 2004.

Pursuant to HAR Section HAR, § 15-15-70(f), the DPP is required to notify the LUC and Petitioner of its position within seven days after being served. The DPP respectfully requests that the deadline to respond to Petitioner's Motion be extended to April 10, 2025.

The request for extension is to allow time for the DPP to consult with appropriate agencies on areas of concern that may be affected by the proposed Petition.
