Dear Director Evans:

In connection with the Second Environmental Impact Statement Preparation Notice ("Second EISPN") for the above-referenced action, we respectfully request the publication of notice of: (1) a second public scoping meeting, and (2) an extension of the public comment period, in the next available issue of *The Environmental Notice*.

As noted in the Notice of Withdrawal and Re-Publication of the EISPN filed on December 27, 2024, in Docket No. A19-807, the Second EIS Preparation Notice for Sanford's Service Center Leilani Quarry was published on January 8, 2025 in *The Environmental Notice*.

The EISPN and Publication Notice provided: "Administrative 30-day public review and comment period starts. Comments are due by February 7, 2025. Please send comments to [LeilaniQuarryProject@g70.design](mailto:LeilaniQuarryProject@g70.design). A virtual public scoping meeting will be held on January 20, 2025; 6:00 - 7:30 PM via Microsoft Teams. You must request a meeting link via email to [LeilaniQuarryProject@g70.design](mailto:LeilaniQuarryProject@g70.design)."

After the public scoping meeting took place, it was discovered that two (2) parties who requested links to the scoping meeting did not receive the link. For this reason, the Applicant and its consultant will be scheduling a second virtual public scoping meeting to take place on **Wednesday, February 12, 2025 at 6:00 p.m.** via Zoom, and requests that the **comment period be extended to end on February 21, 2025** (as opposed to February 7, 2025) to ensure that all those who wish to comment on the EISPN have an opportunity to do so.
